

# Written in the Stars: The Power of Kundali in Love and Marriage

**Abstract:** Astrology, an ancient system of divination, holds intriguing insights into the intricate interplay between celestial configurations and human destinies. This retrospective study aims to explore the profound correlations between astrological parameters and marriage challenges faced by individuals aged 22 to 45.

Through a meticulous analysis of birth charts (D1, D9, D7) and various astrological indicators, this study endeavors to unravel the celestial influences shaping marital trajectories. Astrology encompasses multifaceted tools such as Chardasha, Vimshottari Dasha, and the significance of planets like Dara Karak (DK), Amatya Karak (AmK), and Gnathi Karak (GK) within diverse astrological charts (D1, D9, D7). Additionally, Ashtakvarga, Vimshopak Bala, and planetary placements serve as critical components influencing marital predictions and hurdles within the astrological realm. Employing a retrospective approach, individuals significantly grappling with marital challenges were selected based on age criteria.

The study meticulously analyzed astrological parameters—planetary connections, health, DashaPhal, and Ashtakvarga reflections. Statistical tools were utilized to discern correlations between astrological elements and marital hurdles observed among the participants.

Gnathi Karak (GK) emerged as a pivotal influencer, often superseding the influence of Atma Karak (AK) or Amatya Karak (AmK) and Dara Karak (D7), in causing marital impediments. Stronger prominence of GK, particularly when outweighing AK or AmK and the Dara Karak, correlated significantly with pronounced marital challenges. Negative outcomes were observed when Dara Karak fell into the 6th, 8th, or 12th houses, coupled with GK influences.

The study underscores the paramount significance of GK in shaping marital challenges, indicating its substantial influence on marital hurdles. These findings shed light on the intricate connections between astrological placements, aspects, and Ashtakvarga reflections, offering individuals deeper insights into the celestial influences affecting their marital success.

retrospective analysis. By examining the individual horoscopes of those who have encountered significant marital obstacles, this study aims to unravel the intricate interplay between celestial placements. Through meticulous data collection and rigorous analysis of planetary alignments and their sequences, we aspire to unveil the profound connection between a person's horoscope and the hurdles witnessed in their marital path. The significance of this study lies in its potential to illuminate the cryptic link between one's astrological chart and the obstacles encountered in their

marital issues.

By gaining insights into the hidden influences of planetary health and cosmic alignments, this research endeavor aims to provide individuals with a deeper comprehension of their horoscope's impact on their marital pursuits. Ultimately, this study aspires to equip individuals with the knowledge to navigate and comprehend the underlying causes of their marital hurdles.

### *Chardasha and Vimshottari Dasha*

Chardasha, particularly Vimshottari Dasha, stands as a pivotal component in Vedic astrology. It's a predictive tool that delineates different periods in a person's life, each ruled by specific planets. Vimshottari Dasha, consisting of a sequence of planetary periods, showcases the influence of various celestial bodies during specific periods of an individual's life. These planetary time periods wield significant sway over a person's experiences, including marriage dynamics, challenges, and personal growth. Chara dasha, however, divides the life of an individual into periods controlled by specific rashis. The rashi that controls the dasha in that time period behaves like the first house, pivoting the role of every planet in the lagna chart.

### *Atma Karak, Amatya Karak & Gnathi Karak*

In Vedic astrology, Atma Karak signifies the soul indicator, showcasing the planet with the highest degrees in an individual's chart. Amatya Karak represents the indicator of marriage and partnership dynamics, denoting the planet with the second-highest degree in the chart. Gnathi Karak, on the other hand, signifies the indicator of obstacles and challenges,

revealing the planet with the lowest degrees. These indicators play a crucial role in delineating various aspects of one's life, including marriage paths and hurdles.

### *Significance of Charts (D1, D7, D9)*

Astrology employs various charts, each portraying specific facets of an individual's life. D1, known as the Birth Chart or Lagna Chart, serves as the foundational chart, detailing the positioning of planets at the time of birth. D7, the Saptamsa Chart, focuses specifically on marriage and progeny aspects. D9, the Navamsa Chart, accentuates the finer nuances of one's life, including relationships and spiritual inclinations. Each chart serves as a lens through which astrologers glean insights into different spheres of a person's existence.

### *Ashtakvarga*

Ashtakvarga is a predictive tool that assesses the strength of planets in an individual's chart. It evaluates the planetary transits and their impact on specific houses, signifying the potential areas of strength and weakness in a person's life. This comprehensive assessment aids astrologers in making precise predictions regarding various life events, including marriage fluctuations and challenges. A1 provides the ashtakvarga scoring of the lagna chart and A7 provides the ashtakvarga scoring of the D7 chart.

### *Vimshopak Bala (Rank)*

Vimshopak Bala is a method used in Vedic astrology to determine the strength of planets in a person's chart. It assesses a planet's strength based on various factors, including its position, aspects, and dignities in specific signs. The rank or score derived from Vimshopak Bala aids astrologers in assessing the influence and potency of each planet, offering insights into its impact on different life arenas, such as marriage trajectories.

## III. METHODOLOGY

- Examined individuals' marriage trajectories retrospectively to understand the correlation between astrological parameters and marital struggles.

- DashaPhal Examination
- Studied the outcomes of planetary periods to discern correlations between specific periods and marriage hurdles.

## V. DISCUSSION

- In the charts analysis, it is to be considered very prominently that the 7<sup>th</sup> house, its lord and aspects, the conjunctions play important role in the marital subject. Navansha and saptansha charts (D9 and D7) also give further insight into this.
- The ashtakvarga chart gives a general idea about the ease of this subject in the chart. The points in the 2<sup>nd</sup> house should be less than that of the 7<sup>th</sup> house and the points in the 8<sup>th</sup> house should be more than points in the 7<sup>th</sup> house to ensure positive results.
- The aspect of Gnati karak (GK) on the dara karak (DK) is very important as explained in the individual charts. Even if the GK is related to the DK in aspect, conjunction or dispositor basis, it will affect the marriage subject of the Jatak.
- The running mahadasha (MD) analysis is also explained in the individual charts. If the 7<sup>th</sup> lord from the MD lord is affected by GK or is placed in 6<sup>th</sup>, 8<sup>th</sup> or 12<sup>th</sup> from the MD lord, it will put obstacle in the marriage.
- Similarly in the Jaimini system of analysis, the method of prediction remains the same. Here the aspects of the planet are different from that of Parashari.
- In Jaimini System, the planet in the Char Rashis (1, 4, 7, 10) aspect Sthir Rashis (2,5,8,11) except that just next to it. While the planets in dual Rashis (3, 6, 9, and 12) aspect only the remaining dual Rashis. It has been explained in the individual charts.
- In the Vimshopak table, it is also observed that if the GK is stronger than DK, it also tends to put problems in the marriage subject.

## VI. LIMITATIONS OF THE STUDY

**1. Sample Size and Representation:** The study's scope was limited by the sample size and

demographics, potentially impacting the generalizability of the findings. A larger and more diverse sample could offer a broader perspective on astrological influences on marriages across varied populations.

**2. Data Accuracy and Reliability:** The accuracy of birth details and the reliability of self-reported marriage struggles might have introduced discrepancies in the analysis. Future studies could benefit from more robust data collection methods and validation procedures.

**3. Astrological Interpretation Variability:** Astrological interpretations can vary based on individual astrologers' perspectives and methodologies. The study might have encountered subjectivity in the interpretation of charts and planetary influences.

**4. Scope of Astrological Elements:** The study focused primarily on specific astrological elements like Gnathi Karak (GK), Atma Karak (AK), Amatya Karak (AmK), and Ashtakvarga.
